 - Priority will go to first time speakers, order will alternate pros and cons, and the maker of the motions gets priority once.
 - You cannot interrupt to make a motion.
 - Q: What is a motion?

Review and Approval of FY2024 Budget (45)

Jones, Alvarado

- VP of Finance Nakisha Renee Jones and Director of Budget Rene Alvarado introductions.
- There is a three step process to approve the budget:
 - The GA needs to ratify the provisional budget (typical procedure).
 - Unique to this year, the GA needs to ratify the provost approved version of the provisional budget. This second budget was made by the provost and finance division of GAPSA in the summer when the GA was not in session, and included amendments from the provost.
 - Thirdly, we will go through individual amendments to be made to the second budget and vote on them. Any further amendments can be brought up and will need to go through provost approval again.

- If this is not done today, then GAPSA funds can be subject to administrative holds and not just GAPSA holds. Questions? No funds may be spent after the second GA meeting without approval.
- Key initiatives for the provisional budget were constructed with a survey done of GA44
 members who ranked their priorities for GAPSA funds, along with utilization from last
 year.
- Problems are arising as spending levels are returning to pre-covid years, which is not reflected in last years budget.
- Other changes include scaled back leadership and programming, removal of division development funding so that all community building needs to come through the operations department, and student group event funding cut in half.

• Ratifying the Provisional Budget

Assembly Member: Motion to move to Q and A to ratify the provisional budget. Seconded. All in favor. Motion is adopted

Assembly Member: Were there any areas where the budget increased?

Rene: Increases include 1200 for research group funding, increases in budget for G12+ based on increased full time equivalent enrollment. BGSA funding increased due to now representing non M.D. Masters students.

Assembly Member: How are funds distributed across individual schools?

Rene: Funds are based on full time equivalency.

Assembly Member: To add on, full time status depends on the year in degree program, full time vs part time, virtual degrees or mixed, and tracks how much is paid in student fees. There is a one year lag in numbers to accommodate add and drop.

Gina: Request to return topic of conversation to ratifying the budget.

Point of inquiry: Can you elaborate on when the decisions were made as to when and why the provost is approving the budget.

Rene: Over the summer a budget memo was sent out. A new process will begin next year with provost approval being required due to the transition of GAPSA funds from University Life to the Provost Administrative Office.

Gina: Would anyone like to speak in favor of or against the motion?

Assembly Member: Motion to to ratify the provisional budget. Seconded. All in favor. Motion is adopted by more than three-quarters of present GA members.

• Ratifying the Provost Approved Budget

Moved to Q and A for the provost approved provisional budget.⁴

Assembly Member: Clarifying the reason we're doing this is because the provost approved budget is our starting point no matter what, so ratifying it soon is in our best interest.

Assembly Member: If we postpone the vote, then is the budget stopped? Do we have to say yes now for it to move forward?

Rene: Yes.

Assembly Member: If we wish to recommend an amendment does it need to happen today?

Rene: We are seeking to avoid a delay in further provost approval with any changes made tonight. We will work off new provost budget and amend from there to keep funds from being held up.

Point of inquiry: But the provost needs to approve the amended budget whether it is done tonight or next meeting?

Rene: We will continue to consider amendments so that we have a say in the budget. Today is more about adopting a sweep of amendments so that decisions being made this week can happen. We can still amend and seek re-approval in the future.

Point of inquiry: Where are we procedurally?

Gina: We need a motion to advance to a second reading.

Point of inquiry: Can you elaborate on when the decisions were made as to when and why the provost is approving the budget.

Assembly Member: Motion to move to a second reading.

Assembly Member: Are we not required to have a debate? Do we want to immediately vote?

Point of order: Motion was made and seconded can we move on?

Assembly Member: We would like to discuss the budget first before we get into voting on procedure.

Assembly Member: Motion to move to Q and A. Seconded. All in favor. Motion is adopted to enter Q and A

Point of order: We need to be presented the second budget

Rene re-reviewed summer amendments slide. Reach out to Rene Alvarado and Nakisha Jones with questions.

Assembly Member: For context on procedure: Last year procedure was that all proposition resolutions need to be considered at two separate meetings. This didn't happen for our current budget discussion. So as per the rules we cannot go to a final vote today. To suspend this rule, the question must be urgent or non-controversial. We will need $\frac{3}{4}$ vote for passage.

Nakisha: Further context: The budget went to provost approval and got amended. GA wasn't in session. Now the GA needs to have a decision even though its provost approved. This IS an urgent question because decisions are being made right now about awarding funding.

Assembly Member: So we are just trying to get the stamp on an already approved budget? Nakisha: Yes.

Katherine: I will be voting no. We [the med school] lost 15k and weren't made aware until two weeks ago, and we believe there are FTE calculation discrepancies.

Nakisha presented final slides on current budget.

Assembly Member: Motion to suspend rules and proceed to a second reading. Seconded. All in favor. Motion is adopted unanimously.

Assembly Member: Motion to move to Q and A on the provost approved provisional budget. Seconded. All in favor. Motion is adopted unanimously.

Assembly Member: What is leadership funding?

Nakisha: It comprises pres and exec vice pres funding. For example enhancing student wellness within or outside of exec team. President of GAPSA Michael Krone wants to hold coffee and talk to build community as well. This funding pays for meetings with G12 leaders too.

Point of information: What are pilot funds?:

Nakisha: Shifting priorities mean new things come up before being set in stone. Examples: Meal voucher program, community outreach, funds GAPSA unlimited.

Assembly Member: Utilization numbers, GSC spent 191% of its allocated utilization. Why and how?

Rene: 22k was used for tied fraction commitment around academic programming. Hosting 130+ events for 3388 students. Other funds were 20k for programming in FY24 used for lending library of electronics, equipment to be purchased for printing in common room, activity suite and game room. Late April and May transfers, not requested by GSC but given by VP of programming from last year.

Assembly Member: Follow up to that: GA contemplated these transfers and resolution failed. It appears that the VP of Programming exceeded their authority.

Assembly Member: What does this have to do with approving the budget right now? Provost doesn't care about the funds transferred. We should rubber stamp this budget.

Assembly Member: What are contingency funds?

Nakisha: Contingency funds include our emergency fund, bonus plan, and reserves.

Assembly Member: What are reserve funds?

Nakisha: It contains money for career services for unpaid summer internships, primarily.

Parliamentary inquiry: Are we on debate now?

Point of information: Suggestion to actively show in the slide show what part of the procedure we are on.

Assembly Member: Expressed concern because there is a lack of understanding of the budget. Proposed a subcommittee to look into what happened and how to be sure it doesn't happen again. Motion to ask this body to suspend rules to go through with voting now and will look into this later on within a subcommittee.

Nakisha: We appreciate the sentiment. There was a delay of information due to the GA not being in session. There are lots of committees to join if you'd like to be more involved in this.

Rene: Budget was technically presented in the last meeting and was sent out by email to the GA.⁵

Assembly Member: What is the difference in making amendments now versus later?

Assembly Member: Now we only need majority to amend the budget, after approval we would need 3/4 to pass.

Assembly Member: Against this because 15 minutes will not be enough to get through a single amendment. More productive to do a first presentation tonight and do a second reading next time.

Point of information: Why do we want to pass these quickly? What are the consequences of not passing them all at once or tonight?

Rene: We want to avoid sending amendments once every two weeks and inundating the provosts office, delaying provost approval.

Assembly Member: What are the consequences if we postpone until the next meeting?

Nakisha: Based on the amendments, all of them effect council budgets and council functioning like town halls and retreats.

Michael: Getting though the first two amendments would be great. They'll be non controversial.

Point of inquiry: Where can we send questions in for answer before the next meeting?⁶

Assembly Member: Motion to table, feels rushed.

Assembly Member: Motion to end debate and move to a vote. Seconded. All in favor. Motion is adopted

Assembly Member: Motion to suspend rules and move on to a second reading. 15 say no, 10 say yay. Does not meet three-quarters requirement. Motion is not adopted.

- Requiring Councils to go to other groups for budgetary needs puts them at an
