We'll spend 15 minutes or so discussing in small groups on perspectives on public safety.

- Dan brought the meeting back to order, ready to start the conversation.
- Penn Transit Services vs SEPTA:

Assembly Member: Penn transit is not very user friendly, and we don't know when the Penn bus is stopping, or if it is going to come. We often get to the Penn Bookstore and Franklin's Table bus stop and wait since it shows a bus nearby and on the way, but its

parked and not in service. If there is a way to show if the buses are in service or not that could be very useful information. 2

Assembly Member: Medical complex has the Lucy Loop, something more like Lucy throughout larger areas is an idea. Service areas around Grad Hospital and Center City would be very helpful since a lot of grad students live there as well.

Assembly Member: Does Penn transit offer something SEPTA doesn't? Should we just offer subsidized SEPTA cards?

Penn transit definitely has some stops SEPTA does not, and the door to door shuttle makes it safer/more accessible. Walking escorts are a unique feature of Penn Transit as well!

Assembly Member: Extending service area of the walking escorts or shuttles would be helpful. Updating the map of where students live to redistribute resources is also a relevant suggestion.

Assembly Member: other advantages of Penn Transit³ is that Lucy is already very frequent in the morning, but is more geared towards working people. Another point is that Penn added a Penn North bus recently but is wasn't advertised. Word of mouth is the extent of knowledge sharing.

Assembly Member: Instructions for how to use the Penn Transit App would be great as well.

Assembly Member: Sometimes the shuttles get indefinitely delayed.

Assembly Member: In theory, a 7 min frequency is an ideal interval for buses to come in order to not inconvenience or disrupt movement in a city.

• Potential bias in these deliberations

Assembly Member: Note the bias in this population since the GA has people only available 7pm on a Wednesday night. We're not truly a representative body in that regard, as those who live far away are less likely to be here.

Great point, share the map with others so they can be represented, at least on the map.

Anecdotes on safety

Assembly Member: Something to take back: I've been attacked more in Philadelphia than I have ever been in my life anywhere else.

Did a fist to five for people to express how safe they felt in Philadelphia, a fist being the most unsafe and five fingers being very safe. A lot of 2-3's.

What blocks do you feel the most unsafe on? Please share with Saloni.

General notes: People avoid the MFL. People fight, it stinks, sexual assault. Most importantly and actionable, UPENN alerts need to keep on top of public transit related incidents as they have historically failed to do so.

• Second reading of Bill 6: Research Council Budget Amendment

Full text of the amendment should be in front of you. There is one single resolved clause to merge two line items. Proposal of merging to create Research Individual and Group Grant Fund. No procedural changes, it will just allow flexibility based on demand.

• Q and A:

AEF is a joint between professional and research council. Has this been cleared by professional council?

It's not joint, it's only under the purview of RC. Where it gets confusing is that it's open to not only research student groups, but also professional, for the sake of enriching the entire graduate professional student experience. The fund and applications are not under the purview of the professional council.

What safe guards are there to keep individual grants from consuming the whole fund? ⁴

We have made a verbal agreement that AEF grants will take priority over individual grants. The normal amount of individual grant money will go into individual grants to start, but we will wait to award more money to individual grants until we know that the AEF is underutilized.

Why don't you take money from somewhere else, like the reserves?

We have many more individual grants than we can fund, always. Sometimes, the AEF is underutilized, sometimes not. This is the most self-contained way to add more funds in the case AEF is underutilized, rather than taking from another department to protect the interests of those departments.

It's my understanding that AEF is always utilized?

No, in the years since COVID it has been underutilized. Is this due to advertising? Or other things? We're not sure.

Assembly Member: Despite the verbal agreements made, there's no guard rails in the Resolution at all.

Offer by Ben Glass to add these guard rails textually.

Assembly Member: Regardless of these guard rails, we don't think eradicating the AEF will be constitutionally sound without an amendment to the constitution. To a second point, mid year release will show the utilization levels of different funds and we can maybe revisit then.

Assembly Member: I'd like point out the potential conflict of interest. If administration can divert funds, there is incentive to reject all AEF proposals. That incentive would need to be textually removed.

We would like to re-iterate that the goal isn't to take money away from anyone. Its to make sure it can be made readily accessible to all who need it.

For the record last year: All AEF applications were funded.

Assembly Member: I'd like to point out its not that we don't trust you. The point is this is a matter of fairness and ensuring everyone's interests are equally considered. Therefore, I think we should not go with this as it is written today. I think there can be more cooperative methods between professional council and research council of pursuing increasing individual grant funds.⁵

Motion to end debate and move into voting. All those in favor. All opposed. Does not
make the 3/4 vote to move to a vote on Bill 6. No motion to recount. There will be no
vote, and the Bill fails.

Drafting Committee

• First reading of <u>Bill 7:</u> Budget Timeline and Cleanup

Contents are mostly clerical corrections and aligning budget process to comply with provisional budget deadline of January 31st, and new final budget deadline of March 31st.

First reading of the provisional budget by December 1st so there is time for two readings.

March 31st deadline of final budget, so March 1st GA introduction deadline.

Ratification of previous budget process is retained by second meeting of the year.

Move up the election for executive board elections to allow flexibility.

Expect a red-lined version of the constitution soon.

• First reading of Bill 8: Process and Rules

Contains substantive changes to some of the rules. Could be more controversial.

Discussion on removing the ability for the GA to suspend the requirement for two readings.

Assembly Member: This is not something I support.

The rule is often abused, and exec board can act if its actually necessary.

Exec procedure: the board has authority to act when the GA is not meeting. When the exec does act on behalf of the GA, it must be presented to the GA and GA can vote it up or down.

Assembly Member: for context last year, common practice was trial by "ambush" meaning a lot of information was given with not enough time to fully process and understand the bill.

Why is the current requirement of 3/4 not enough?

Note: think about this, but lets let this sink in for next meeting. Continue conversations offline.

What have we seen that has truly required the suspension? Deeply consider why we need it, how has it benefited us, how has it harmed us.

To the last point: these two reading protections have been put in to protect GA from Exec steam rolling.

• Discussion on ticketing refunds and transfers.

Revenue rules: tickets are non refundable and non transferable. What is the reason for that? Students have classes or exams is there no room for flexibility?

It wasn't feasible for us to do. Enables people trying to resell tickets at a markup.

Making this a formal standing rule prevents from unfair enforcement of the already existing unofficial rule.

RE: Research Council Budget Amendment

ABSTRACT:

GAPSA budget amendment to merge line items 6.5 (Research Individual Funds) and 6.6 (Research Group Funds) into a single line 6.5 (Research Individual and Group Grant Fund) to improve allocation and adjust for variation in application volume.

WHEREAS, Research Student Travel Grants, funded entirely by line 6.5 (Research Individual Funds), are among the most applied for and highly competitive grants, with less than one-third of the applications receiving funding on average, and are experiencing a significant increase in demand; and

WHEREAS, The Academic Event Fund, funded entirely by line 6.6 (Research Group Funds), experiences significant variations in spending depending on application volumes and funding cycles set by GAPSA Finance; and

WHEREAS, A merged budget line item for Research Council grants would create more opportunities to enable research students to attend conferences and workshops, promoting equity and diversity by providing flexibility in cases of variation in application volume; and

WHEREAS, The budget amendment process has become more complex and time-consuming due to additional approvals required from the Office of the Provost; now, therefore, be it

RESOLVED, That the GAPSA budget is amended by merging line items 6.5 (Research Individual Funds) and 6.6 (Research Group Funds)—redesignating line 6.7 (Research Council Development) as line 6.6 (Research Council Development)—into a single line item 6.5 (Research Individual and Group Grant Fund) with the allocation equal to the sum of the two current allocations of lines 6.5 and 6.6;

Abstract

The Drafting Committee was constituted by the GAPSA General Assembly on March 15, 2023. This report was prepared over the summer and fall, incorporating the previous report of the Drafting Committee, GA/C.D/44/M/3, recommended amendments to the GAPSA Constitution discovered upon the committee's work compiling the most recently adopted set of amendments, and memorialization of changes to the budget process. This Bill is the first part of three of the committee's report.

These constitutional amendments align the budget timeline; modify the schedule for elections; clarify notice requirements, apportionment, the Executive Board Bylaws amendment procedure, the Deputy Director for Revenue role description, conflict of interest rules, the appointment of the Drafting Committee chair; streamline rules of procedure; and fix errata.

RESOLVED, by the Graduate and Professional Student Assembly of the University of Pennsylvania,

Section 1. That the amendments in this instrument are applied sequentially and take effect simultaneously, even if this instrument is divided and voted on in separate questions at the same meeting; all punctuation included quotes is literal and interpreted as the content of the quote, not as part of the enacting sentence;

1 Budget Timeline

Section 2. That Articles VIII(A)(1) and VIII(A)(2) are substituted by the following:

"(1) Budget Process

- "(a) Vice President for Finance shall, with the advice of the Committee on the Budget, on or before December 1, present a proposed budget Bill for the next academic year. Upon approval by majority vote of the General Assembly, this becomes the preliminary budget.
- "(b) Vice President for Finance shall, on or before March 1, present a second proposed budget Bill, based on the preliminary budget. Upon approval by majority vote of the General Assembly, this becomes the provisional budget.
- "(c) Prior to the second regular General Assembly meeting of the fall term, the Vice President for Finance shall re-present the identical provisional budget (save for secretarial corrections authorized by the form of the budget). Upon ratification by majority vote of the General Assembly, this becomes the final budget. The provisional budget cannot be amended before its ratification, though the General Assembly may reject it and instruct the Vice President for Finance to prepare and present a new budget to be ratified by the General Assembly.
- "(2) The full text of any budget Bill must be distributed with ten (10) days' notice before the final vote and any allowed amendments thereto require a three-fourths vote with ten (10) days' notice of their full text. No GAPSA funds may be spent after the second regular meeting without General Assembly ratification of the budget.

Section 3. That Article VI(A)(1)(c)(1)(a) is amended—

- (a) by striking out "and spring terms" and inserting "term";
- (b) by striking out "provisional";
- (c) by striking out "in the spring";

2 Election Timeline

Section 4. That Article IV(A)(1)(a) is amended by striking out "at the antepenultimate regular meeting of the spring term" inserting "in the spring term, no later than the antepenultimate regular meeting";

3 Minor Changes

3.1 Simplification

Section 5. That Article II(A)(3) is amended by striking out "The results of any review of the apportionment of seats in General Assembly shall take effect on May 1 of the year in which the review was conducted." and inserting "The reapportionment shall take effect on May 15.";

[&]quot; provided, the amendments in this section take effect for the 2024–25 academic year, and are followed as closely as possible for the 2023–24 academic year.

"

- **Section 6.** That Article II(A)(3) is amended by striking out "For purposes of apportionment only, students shall be divided into three categories: professional students, research students, and students who are IDEAL constituents.";
- **Section 7.** That Articles II(E)(4) and II(E)(6) are stricken out and the remaining paragraphs in Article II(E) are redesignated appropriately;
- **Section 8.** That Article III(C) is substituted (renaming it "Executive Board Bylaws") entirely by the following:
- "(1) The Executive Board is authorized to have Bylaws which govern its day-to-day functioning and such other functions as authorized by this Constitution.
- "(2) The Executive Board Bylaws may be amended by a two-thirds vote of the Executive Board and a majority vote of the General Assembly with ten (10) days notice of the full text, both on the same language.

Section 9. That Article V(J)(3)(b) is amended by striking out "in the manner required for notice per Article XII(B)(2) within 48 hours or before the relevant deadline, whichever is later, (or another period as they may previously determine and announce)" and inserting "within 48 hours";

3.2 Clarification of Original Intent

- **Section 10.** That Article II(G)(6) is amended by adding "The Speaker is not an executive officer or Executive Board member and may not represent GAPSA in their official capacity in meetings with administrators or partners." at the end of the paragraph;
- **Section 11.** That Article III(E)(1) is amended by striking out "two-thirds" and inserting "three-fourths";
- Section 12. That Article V(C)(8) is amended by striking out "maintain and manage" and inserting "assist with the maintenance and management of";
- **Section 13.** That Article V(C)(8) is amended by inserting ", all" before "as directed by the Vice President for Finance";
- **Section 14.** That Executive Board Bylaws Article 7.1.1.2 is amended by inserting "and Council Chairs" after "Vice Presidents" (to insert the complete definition of Level 2 officers per Article 2.2.2);

3.3 Correcting Edge Case Behavior

Section 15. That Article III(B)(8) is amended by inserting "(not *ex officio* of their GAPSA office)" after "Any officer of GAPSA with a leadership position" and before "in any GAPSA-funded group";

Section 16. That Article VI(A)(5)(b) is amended by striking out "by the Parliamentarian" and inserting "by a member thereof the committee shall appoint";

4 Cleanup of Notice Requirements

- **Section 17.** That the Constitution is amended by striking out all instances (5 in the Constitution before any amendments in this Bill) of "previous notice" and inserting "notice";
- Section 18. That Article III(C)(1) is amended by striking out "simple majority vote of the General Assembly" and inserting "majority vote of the General Assembly with ten (10) days' notice of the full text";
- **Section 19.** That Article VI(B)(1) is amended by striking out "simple majority vote of the General Assembly" and inserting "majority vote of the General Assembly with ten (10) days' notice of the full text";
- Section 20. That Article VIII(A)(3) is amended by striking out "Bills that alter" in the phrase "The full text of Bills that alter any spending authority, authorizations, or provisions" and inserting "motions that alter or suggest altering";
- **Section 21.** That Article XII(B)(2)(a) is amended by inserting ", distribution," after "If a measure requires previous notice" and before "or announcement to the General Assembly";
- **Section 22.** That Article XII(B)(2)(a) is amended by striking out "sent" and inserting "distributed/sent";
- Section 23. That Article XII(B)(2)(a) is amended by inserting "(to each officer's official GAPSA electronic address and each other member's electronic address in the Penn Directory)" after "electronic mail";
- **Section 24.** That Article XII(B)(2)(a) is amended by inserting "if notice of the full text is not required," after "(2)" and before "announced at a meeting of the General Assembly and entered on the minutes";
- **Section 25.** That Article XII(B)(2)(a) is amended by striking out ", or (3) delivered by a method the General Assembly has approved by three-fourths vote" and by inserting "or" before "(2)";

Section 26. That Article XII(B)(2)(a) is amended by inserting "The default minimum notice is thirty-six (36) hours unless otherwise specified." at the end of the subparagraph;

Section 33. That Article II(D)(3) is amended by moving each of the five (5) sentences of the paragraph (3) to a new subparagraph (designated (3)(a), (3)(b), (3)(c), (3)(d), and (3)(e)) and naming the paragraph "Procedure";

Section 34. That Article II(D)(3)(e) is amended by inserting "the sole function of which is to deprive members of their right to speak in debate" after "most exceptional procedure";

Section 35. That Article II(D)(9)(a) is amended by striking out "draft";

Section 36. That Article II(D)(9)(a) is amended by striking out "Budget" and inserting "budget";

Section 37. That Article II(D)(9)(b) is amended by striking out " (but may also be rejected outright by a motion to postpone indefinitely)." and inserting ". A Bill may also be rejected outright by a motion to *Reject at First Reading*, subject to the same procedural rules as *postpone indefinitely*.";

Section 38. That Article II(G)(3) is amended by striking out "Executive Officers" and inserting "executive officers";

- **Section 39.** That Article II(G)(5) is amended by striking out "if the Speaker is vacant or unwilling" and inserting "if the Speaker is unable or the office of Speaker is vacant";
- **Section 40.** That Article III(A)(1) is amended by striking out "according" and inserting "corresponding";
- **Section 41.** That Article III(B)(1) is amended by striking "successors are elected" and inserting "successors are elected or appointed, respectively";
- **Section 42.** That Article III(B) is amended by adding paragraph (9) "Voting members of the Executive Board may not be General Assembly Representatives.";
- **Section 43.** That Article IV is renamed "Elections and Appointments";
- **Section 44.** That Article IV(A)(2) is amended by striking out "(6) Vice President for Advocacy, and (7) Speaker" and inserting ", and (6) Vice President for Advocacy";
- **Section 45.** That Article V is renamed "Executive Officers";

The Drafting Committee was constituted by the GAPSA General Assembly on March 15, 2023. This Bill also proposes changes which refine budget authorization rules and implement ticketing rules.

Abstract

The Drafting Committee was constituted by the GAPSA General Assembly on March 15, 2023. This report was prepared over the summer and fall, incorporating the previous report of the Drafting Committee, GA/C.D/44/M/3, recommended amendments to the GAPSA Constitution discovered upon the committee's work compiling the most recently adopted set of amendments, and memorialization of changes to the budget process. This Bill implements the first set of Bylaws for the Drafting Committee.

RESOLVED, by the Graduate and Professional Student Assembly of the University of Pennsylvania, by majority of the General Assembly and consensus of the Drafting Committee,

Section 1. That the following Drafting Committee Bylaws are enacted:

- "(1) Advice on Legislative Process. The committee should advise members of GAPSA—
 - "(1.1) on the notice deadlines for bringing measures to the General Assembly;
 - "(1.2) how to write up an idea into a resolution, taking care to emphasize—
 - "(1.2.1) concision and clarity;
 - "(1.2.2) the distinction between preambulatory (e.g., "whereas") and operative clauses;
 - "(1.2.3) the inclusion of references to the authority on which an action is taken;
 - "(1.2.4) that budget reallocations be fully specified;
 - "(1.2.5) that motions and amendments to motions be written out in full properly;
 - "(1.2.6) that documents be specifically identified with version numbers from the Standardized Symbol System, in accordance with Article XII(B)(1)(d); and
 - "(1.2.7) that Constitutional Amendments include official abstracts for insertion into Article XIII;
 - "(1.3) on the primarily used motions and processes in meetings by preparing a summary card and/or sheet.
- "(2) Committee Opinions. The Drafting Committee shall be automatically referred all matters regarding controversies about the application of the rules of GAPSA outside of General Assembly meetings, for the issuance of an opinion specifically describing the rules applied to the case, before their consideration by the General Assembly.
- "(3) Committee Operations. The Drafting Committee is authorized to meet by videoconferencing technology that is accessible to all members of the committee. The Committee should ordinarily meet regularly in the week prior to General Assembly meetings, to review upcoming Bills.
